## PASTOR'S LETTER

Dear Christ Church,

It's been a long month since we've been apart. We haven't been able to gather in person for worship, activities, and other important parts of church life. I miss you. Because you may be wondering what your pastor has been up to, I want to take some time to walk you through a typical week at Christ Church during COVID-19.

Before COVID-19, it would generally take me a couple days to put together a Sunday morning worship service. I used to have to submit a service to our Office Administrator by Thursday so she could print the final bulletins by Friday afternoon. Today, however, I have to put together two services by the beginning of the week, so we can mail copies out to some of you and email them to the rest before Sunday. This means the sermon that I would normally work on all weekend has to be completed by Wednesday. Because you are spending more time *looking* at written things from church, Debbie and I have spent extra time finding art, videos, and other worshipful things to improve your devotional experience.

The real fun begins after the service has been put together in print. It takes me nearly an entire workday to record a 45-minute worship service. This process takes longer if musicians are involved because I have to schedule an appointment for them to come to church and record their music. After they finish recording, I have to edit the recordings using special sound editing software so that they are acceptable for adding to the final product. Whenever I record videos, I have to adjust the camera settings, lighting, sound, and angle between every segment of worship. All of this is done from my personal laptop. You should seriously see some of the outtakes! One of these days I will make a blooper compilation and share it on Facebook. I am hopeful I can look back on this experience and laugh someday.

The challenging part starts after worship has been recorded. I use a video editor to create a storyboard of all the different movements of worship such as the call to worship, sermon, songs, blessings, and so forth. After I have an order of worship established on the storyboard, I have to trim each video clip, sort of like I am cutting up film.

When the clips are in the correct order and trimmed down, I superimpose graphics, text, transitions, and other visual flourishes into the video to make it look slicker. When this is complete, I add music to the video by importing and adding the audio files that I recorded with our musicians *into* the video. The hope is that this gives you a more meaningful and familiar sounding worship experience.

Once the video is finalized, I export it to my computer. This creates a gigantic video file that can take sometimes over an hour, as it renders each frame in real time. This means if a video is 45 minutes in length, it takes 45 minutes to render from start to finish. After the video renders, I *usually* watch it to make sure there are not any errors. If there are, I must revisit the video editor, fix the issue, and render it all over again. Sometimes this process takes several hours.

When the video is rendered and passes my inspection, I can put it on YouTube. Because the video files are generally quite massive, this process takes at least an hour. When this finishes up, I create a “Premier Video” on Facebook with the movie. This takes another hour as the video has to upload to Facebook. This feature allows us to watch the worship service together on Sunday morning. When everything is uploaded to YouTube and Facebook, I send out the devotionals to you in your email and post a message in Facebook. Hopefully, I remembered to blind carbon copy you all! Finally, when all this is finished, I let out a sigh of relief and pour a large glass of red wine.

The process of creating a worship service, recording, editing, and uploading the services takes several days, but it is a labor of love. While Debbie and I put together the services for the week, we make calls and emails to check in on you and get prayer requests together for the services. We also have been putting together devotionals that go out on Facebook for you and your families to enjoy, as well as art and activities that can be done at home.

We are hopeful that our hard work has paid off for you and your families. We continue to diligently operate as best as we can with limited resources, tools, and time. We are thankful for your grace and patience as we have learned how to navigate through COVID-19 together as a church and staff. As we continue to lean into the reality of being the Church in a pandemic, my hope is not only to provide you the spiritual nourishment that you need to get through the week, but about what our path forward will look like this summer and beyond.



## COVID-19 AND CHRIST CHURCH

It's been a long 6-weeks since we've been apart. I hope you and your families are staying healthy in body, mind, and spirit during these trying times. At this time, I would like to give you some updates about what we've been up to at Christ Church and some important considerations for how our decisions about the future will work, given the federal government's gated criteria for reopening the country.

But first, here is a bit of ancient history. At the beginning of March, the Church Council and I met to discuss a path forward for worship, activities, and church operations given the developments surrounding the pandemic. We agreed at that time that it would be best to suspend in-person worship and gatherings at church until it is deemed safe by the public health, denominational, ecumenical, and government officials. Within hours of our first meeting, Governor Evers declared the safer at home order. We are proud to have taken this order seriously and believe it is an expression of our love of neighbor. With the encouragement of the Council, I developed an action plan and have largely stuck to it, with the exception of a few items changing here and there about the frequency of devotionals.

Ever since we decided to suspend in-person worship, events, and activities - Debbie, our church office administrator, and I have hit the ground running to put together worship services for two distinct groups of people. We put together a service for computer and technology users, and a hard copy for persons who would prefer to receive something in print. A weekly worship bulletin is mailed on Thursdays and emailed every Friday.

What started off as a simple recorded service now requires several days to complete from start to finish.

I have been posting devotional materials to Facebook several times a week.

We began hosting Zoom coffee hour services together after worship every Sunday at 10:30 am.

Debbie and I have been working our way through the church directory, calling, and emailing everyone possible with the contact information we have.

Even though we have not been able to connect in-person - there has been a great deal of *reconnection* taking place at Christ Church. Whether through Zoom, Facebook, our weekly newsletter, or the monthly *Chronicles* mailing - people seem to be reconnecting with us after long departures or connecting with us for the first time during this crisis. That is a hopeful thing.

To be blunt, COVID-19 has negatively impacted the church's financial health. We did not gather in person for Easter this year and we will feel the impact of that throughout the summer and fall. This was a responsible move on our part, but it has real ramifications for the church's financial solvency. Furthermore, when the economy struggles, we *all* tend to tighten our belts a bit - and it can be hard to be generous when you feel anxious about giving.

To seek relief from the pandemic, our church's ad hoc financial team, consisting of our church treasurer, financial secretary, stewardship chair on council, accountant, and myself applied for one of the federal government relief programs CARES act small business loans. Unfortunately, the program ran out of money before we could even submit our application. Fortunately, we have completed the application, submitted it, and are waiting in the queue in the event that more relief becomes available.

We also had General Fund money available in our endowment that was put aside specifically for the future of the church, which we were able to draw from to help pay our immediate overhead expenses. This was a short-term solution. Your consistent, generous giving are the long-term solution that will help your church weather this crisis. Thankfully, many of you have generously donated, even without us worshipping together in person. For that, I am thankful.

Finally, I want to discuss the future of the church, with respect to the 3-phase plan the federal government recently released about opening the country again.

Given the federal government's criteria for reopening the country, places of worship can reopen if they observe strict social distancing during **phase one**. Just because the government says its acceptable to open, it doesn't mean that it's safe for *us* in our particular church, to open. And friends, as much as I would love things to go back to how they were in February – that time is over.

Worshipping in person may look different than it did before Ash Wednesday when we last gathered. What will church look like with social distancing measures put into place? Will it still feel like church? Strict social distancing measures means we will have to have people sit apart from one another in the pews, wear PPE, potentially eliminate paper bulletins or anything that you might touch, restrict bathroom use, refrain from serving food, and put a cap on the number of people who can be in the sanctuary at church at a time. As your pastor, I want you to know that I am more concerned about your health and safety *in the church* than our government is.

The church council and I will take the federal government's guidance into consideration. However, we must also make an informed decision about when we will open our church for worshipping in person along with various other factors such as our state leader's guidance, what our neighboring churches are doing, the guidance of the Wisconsin Council of Churches, and local authorities. We want to make sure that when we do settle into a new normal with in person worship, that it can be meaningful, but most of all, that it will be safe and we will not contribute to the spread of disease.

With this being said, it feels like a lifetime ago that I first sat down in my office after admiring the empty church, and spoke to you from the heart about what our plan would be as a church moving forward into this pandemic. As the situation continues to develop and the administration, state and local government, and church leaders for the UCC and Wisconsin make details and plans available, we will continue to act decisively for the wellbeing and future of Christ Church.

Until we see one another again. Remember – germs and Jesus are everywhere.

~The five healthcare workers within our immediate family and we are grateful for the recovery of one of them from COVID-19. From, Gloria Konkel.


~Dawn Dayton, Brad Dayton's wife who is going thru some serious health issues. Prayers that she does not contract COVID-19 as it could be fatal for her.

you can do on a rainy day.*


*You will need:*
